"Gold Dust" is a name given to hydrophyllic beads, fashioned like the Bard Absorption Dressing or the Debrisan beads that those of us who have been around the block may remember. Gold Dust, like those products, absorbs many times it's weight in exudate. These hydrophyllic beads aren't used as much today, replaced by alginates, foams, and the VAC. I, for one, always thought they were a much more cost-effective way of controlling excess drainage. When these beads/granules mix with exudate, a soft gel forms, conforming to the wound bed and provides controlled moisture to the wound. The same principles follow as with all moist wound environments.

The down side of using these products is the way it is delivered, in a bead/granular form. It is much easier to apply an alginate for instance. However, one can premix it, if desired, with a little water or saline, stir it and put in the wound wet vs. dry. Of course, if you do that, it will absorb less than putting it in dry form.

But the upside is they are cheaper, I think they handle MORE drainage, not less, and do a much better job at controlling odor. I personally use it as a standard in pilonidal cysts wounds. I use to use alginates, foams, etc, but found Gold Dust and Elastogel to better handle the drainage in these usually infected, odorous wounds. Even though patients have to rely on caregiver support to put the beads in, they heal much faster, have better pain control, less dressing changes and odor is eliminated.
